Keezlenutten Farm will be offering a ½ day camp for children ages 7-10. No previous riding experience is necessary. There are two weeks available: June 27th – July 1st and August 8th – 12th. Campers need to arrive by Keezlenutten Farm by 9:00 am and be picked up by 1:00 pm. The cost of this camp is \$200.00 per student. There will be a maximum of 12 students, availability on a first come, first served basis held by a \$50.00 deposit. We also offer a full day camp for beginners as well as advanced students that are at least 8 years old. If you, or someone you know, is interested in receiving information about this camp, please contact me. Please note that there are only two weeks of ½ day camp available this year, so make sure to register early to reserve your spot.

The schedule during the week will be as follows:

9:00 – 11:00 Riding lesson (students will be broken up into groups based on their skill level)
11:00 – 11:30 Untack and groom horses
11:30 – 12:00 Lunch (pack your own)
12:00 – 1:00 Learning project or craft

**On Friday, family and friends are invited to watch the exhibition starting at 12:00.
All campers will participate.**

During their stay, students will work on the following:

- Grooming & tacking up a horse
- Basic riding skills
- Basic care of a horse
- Horse related crafts

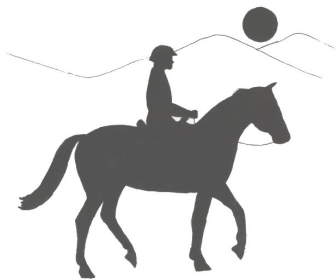
This will be a great experience for the younger rider, giving them an opportunity not only to improve their riding skills, but also learn how to care for a horse.

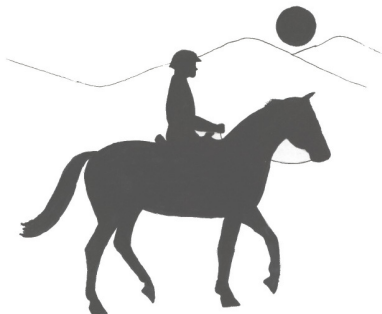
